A Request for Proposals (RFP) was mailed and advertised March 4, 2019. The RFP's were due on April 12, 2019 and we had 8 responding vendors and 1 vendor who responded with a NO BID. As you can see in the enclosed documents, our committee narrowed the 8 responses to 3. The 3 finalists came and presented their RFP's to our committee.

The committee recommends awarding the school fleet, and the print shop 2 color pieces to Konica Minolta. All three vendors were exceptional, but as you can see from our point system, KONICA just came out on top.

This contract replaces all our current equipment, adds Papercut MF software, and includes all service and toners on all machines. The awarded contract should save our District over \$60,000.00 per year, so \$300,000.00 over the life of the contract.
